#### **Treasures Report** Roland Cheramie

Reported the Volunteer Credit account has \$3,565.00 and is designated for refunds to volunteers. Funds not available for to use.

As of January 1, 2023 we had \$3,637.15 in our checking account and \$71,877.95 in our savings account for a total of \$75,515.10. The annual Executive Board meeting and workshop for January, 2023 was held in Rockport, Texas costing \$4,539.25 vs. the \$5,000.00 budgeted.

So far this year, we have income of \$28,937.28 from Commercial and Family registration, \$500 from FMCA RV Insurance and \$35.92 from savings interest for a total of \$29,473.20. There are 97 Family registrations and 4 Commercials.

Expenses of \$6,236.64 include the \$4,539.25 Executive Board meeting in January, site visit of \$300.45, a deposit of \$750 for the Renegade band, \$331.48 flowers and plants for 3 funerals, and \$315.46 for other administrative expenses. So, we have a net income of \$23,236.56 through June 30, 2023.

Our bank checking account has a balance of \$2,235.97 while the savings account has \$96,884.15 for a total of \$99,120.12 with \$368.46 in uncleared checks giving us a register balance of \$98,751.66.
